

A BILL FOR AN ACT

To amend section 8 of Public Law No. 19-118, as amended by Public Law No. 19-125, in order to clarify the use of UN membership fees subsidy and related contributions, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 8 of Public Law No. 19-118, as amended  
2 by Public Law No. 19-125, is hereby further amended to read as  
3 follows:

4 "Section 8. Grants, Subsidies and Contributions. The  
5 sum of \$11,916,234, or so much thereof as may be  
6 necessary, is hereby appropriated from the General Fund  
7 of the Federated States of Micronesia for the fiscal  
8 year ending September 30, 2017 for the following grants,  
9 subsidies and contributions during fiscal year 2017.

10 The sum appropriated by this section shall be  
11 apportioned as follows:
